ELIGIBLE COMPETITORS: All competitors must be holders of a current, valid and relevant Racing Licence & Medical Certificate, applicable to the event, its status and/or championship or race in question. Licences and Club Membership Cards will be examined at signing-on. The event is open to fully paid up valid card holding members of: BTRDA, CDMC, NEACC, BARC & D&DMC, plus invited drivers from the MDA (Minicross Drivers Association), CKMC (County Kildare Motor Club), and CMC (Carlow Motor Club).

INVITED CLUBS / CHAMPIONSHIPS: BTRDA, CDMC, NEACC, BARC & D&DMC, MDA, CKMC & CMC

ENTRIES AND STARTERS: The organisers have the right to select or refuse entries as they see fit. The maximum number of entries for the meeting is 120. The Minimum is 40. Should any of the minimum figures not be reached the organisers have the right to cancel or amalgamate races or classes as necessary.

ENTRY DEFINITIONS: Each basic entry will qualify for 6 personnel passes for the meeting. Each entry will qualify the competitor for a listing in the official programme of the Entrant / Sponsor / Team name. This listing will be to a maximum of six words and must contain no offensive or misleading statements and all other restrictions on types of advertising must be respected, MSA H28. For all entries made supported by an International or National Entrants Licence, the listing in the programme must match the title on the Entrants Licence. ACCEPTANCE / REFUSAL OF ENTRIES: Entries will be accepted up to the closing date specified on this form subject to the maximum numbers specified above. Electronic entries will only be accepted if they are sent in accordance with MSA D12.2. All entries received, will be held in abeyance unprocessed, if they are incomplete or are not accompanied by the entry fee. <u>No entries will be</u> accepted after 12.00 noon on Wednesday 9th May 2018 unless a prior arrangement has been <u>made by the competitor concerned</u>. As part of the criteria for agreeing to any revised deadline, an entry form and payment must be received by the Secretary of the Meeting. Any change of entry must be in accordance with MSA D25.1.12.

RESULTS AND PROTESTS: Provisional results will be published as soon as possible after each qualifying session and race at Race Administration. Protests should be made in accordance with MSA C5.

SCRUTINEERING ETC.: All vehicles must comply with MSA Vehicle, Formula and Tyre regulations. Competition numbers must conform to MSA Vehicle regulations. Parc Fermé is located next to the Scrutineering Bay.

REGULATIONS: All other Regulations of the MSA, Championship Regulations, BARC Standing Supplementary Regulations, BARC Health and Safety Guidelines and any other SR's issued by the organisers must be ahered to at all times.

AWARDS: As per Championship Regulations.

INSURANCE: All competitors are insured in respect of Third Party liability during official practice and racing. For further details see the current MSA Yearbook.
